VILLAGE OF WESTON, WOOD COUNTY, OHIO ORDINANCE NO. 2022-22

AN ORDINANCE ESTABLISHING MUTUAL AID FOR FIRE AND EMERGENCY MEDICAL SERVICES, AND DECLARING AN EMERGENCY

Whereas, the Village of Weston, (Village), is a statutory municipality located entirely in Weston Township, Wood County, Ohio, with powers of local self-government pursuant to Ohio Constitution Article XVIII, Section 3, and

Whereas, the Council of the Village of Weston presently participates with other villages and townships in mutual aid for additional fire and emergency medical service protection (Services), and

Whereas, the Village of Weston desires to renew its Mutual Aid Agreement for Additional Fire and Emergency Medical Service Protection (Agreement).

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of Weston, that:

Section 1. There is hereby approved and adopted a Mutual Aid Agreement for Additional Fire and Emergency Medical Service Protection, in a form substantially similar to the attached Exhibit.

Section 2. The Village Mayor and Clerk/Treasurer shall execute the attached Mutual Aid Agreement for Additional Fire and Emergency Medical Service Protection, and any other agreements or amendments thereto as is necessary to accomplish the goals of the Agreement.

Section 3. This measure is an emergency measure necessary for the immediate preservation of the health, safety and welfare of the Village and its residents for the reason that having in place a mutual aid agreement is important to ensure all residents are protected in the event of fire or needed emergency medical assistance. There are an insufficient number of regularly scheduled council meetings in order to have the Agreement in place before the effective date of the Agreement.

Section 5. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any other committees that results in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Revised Code of Ohio.


