# ANNUAL APPROPRIATION ORDINANCE (Revised Code Sec. 5705.38)

ORDINANCE PROVIDING PERMANENT APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES FOR THE VILLAGE OF WESTON, OHIO, THROUGH DECEMBER 31, 2026

WHEREAS, the Village of Weston is a statutory village located in Wood County, Ohio, and
