VILLAGE OF WESTON, WOOD COUNTY, OHIO ORDINANCE NO. 2025-21

AN ORDINANCE TO RETAIN THE SERVICES OF THE WOOD COUNTY SHERIFF

WHEREAS, the Village of Weston is a statutory village located in Wood County, Ohio and

WHEREAS, the Village of Weston has powers of local self-government pursuant to Article XVIII, Section 3 of the Ohio Constitution, and

WHEREAS, the Wood County Sheriff's Office is a state-certified law enforcement agency.

WHEREAS, the Village of Weston presently receives law enforcement patrol services from the Wood County Sheriff, and such services are limited to 40 hours per week, and

WHEREAS, the Village of Weston desires to continue receiving law enforcement patrol services from the Wood County Sheriff and establish limits to such services.

NOW, THEREFORE, BE IT ORDAINED, BY THE COUNCIL OF THE VILLAGE OF WESTON, WOOD COUNTY OHIO, THAT:

SECTION 1. The Council hereby authorizes the services of the Wood County Sheriff's Office for law enforcement patrol services in the Village of Weston. Said law enforcement patrol services shall be limited to 26 hours per week, beginning January 1, 2026.

SECTION 2. Compensation for said law enforcement patrol services is hereby approved in an amount consistent with the rate schedule provided by the Wood County Sheriff's Office, presently \$52.87, and as may be subsequently modified by the Wood County Sheriff and by affirmative vote of the Council. The Mayor is authorized to execute, on behalf of the Village, one or more agreements with the Wood County Sheriff for such law enforcement patrol services, if required by the Wood County Sheriff.

SECTION 3. The hour limits established herein may be modified by affirmative vote of the Council, consistent with the terms of an agreement between the Village and the Wood County Sheriff.

SECTION 4. It is hereby found and determined that all formal actions of Council concerning and relating to the passage of this Ordinance were adopted in open meetings of this Council and that all deliberations of this Council and any of its committees that resulted in such a formal actions were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Revised Code of Ohio.
