- Brandon Evans from RLCAP presented funding options for the drainage project on Sycamore. WPCLF (Water Pollution Control Fund) is a forgivable loan but Mr. Evans felt this project was too small, as a stand alone project to qualify for this
OWDA (Ohio Water Development Authority) has a loan program that requires engineering and it would have to be paid back.
.OPWC was presented but it was the opinion of the committee that this project has a more immediate concern.
- GLCAP does offer a GIS program and will be providing a quote. We would have to provide all locations that we are interested in and GLCAP would map the whole system.
- There is a small gas leak at the corner of Silver and Oak St. Suburban Natural Gas is aware, checking on it regularly and appears the plan is to remedy it in the near future.
- Discussed current projects: Potholes on Taylor Stm(by Silver St alley)., Silver St (13310 Silver St), near railroad tracks on Walnut, Washington St.
- Paving of parking lot behind the library (grant Project): A quote from Kleinfelder for a start to finish project. Was expected to have the quote by 2/27/25 in order to submit for the grant. There was a discussion to the businesses response to parklets.
- Request a quote from Toledo Edison for the installation of new streetlights at Poplar Street, Orange Street, Beech Street, Main Street, in front of Cresset Chemical. Additionally, inquire about lighting options for the east side of Sand Ridge Road.
- Discussed the process of getting quotes from contractors.
