

**VILLAGE OF WESTON, WOOD COUNTY, OHIO
ORDINANCE NO. 2022-1**

ORDINANCE AMENDING CEMETERY SEXTON COMPENSATION

WHEREAS, the Village of Weston is a statutory village located in Wood County, Ohio, and

WHEREAS, the Village of Weston has powers of local self-government pursuant to Ohio Constitution Article XVIII, Section 3, and the Ohio Revised Code, including the power to establish and operate, with a cemetery board of trustees, a cemetery, and

WHEREAS, the Council of the Village of Weston has created the position of Cemetery Sexton and by ordinance 2018-17, and later ordinance 2019-24, established a salary therefore, and

WHEREAS, the Council of the Village desires to modify the aforementioned salary.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of Weston, Wood County, Ohio, that:

Section 1: Effective January 1, 2022, the Weston Cemetery Sexton shall be paid an annual salary of Eighteen Thousand Seven Hundred Twenty dollars (\$18,720), payable over 26 equal installments. In addition, the Sexton shall be entitled to an annual uniform allowance of two hundred fifty dollars (\$250), payable in two equal installments on the last pay period in June and December. The salary and uniform allowance shall be prorated in the event of partial year employment.

Section 2: All ordinances, policies, provisions, and conditions amended hereby or inconsistent with this ordinance are hereby repealed.

Section 3: This Ordinance, and the rates established hereby, shall become effective the first day of January, 2022.

Section 4: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any other committees that results in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Revised Code of Ohio.

Section 5: This ordinance constitutes an emergency measure necessary for the immediate preservation of the public welfare due to the need to provide continuing Village cemetery operations and services, and therefore, shall go into immediate effect.
