VILLAGE OF WESTON, WOOD COUNTY, OHIO ORDINANCE 2021-9

ORDINANCE COMBINING THE POSITIONS OF FISCAL OFFICER AND CLERK, ESTABLISHING COMPENSATION, REPEALING ORD 2020-18, AND DECLARING AN EMERGENCY

WHEREAS, the Village of Weston is a statutory municipality located in Wood County, Ohio, with powers of local self-government pursuant to Ohio Constitution Article XVIII, section 3, and

WHEREAS, The Village of Weston has adopted Ordinance 2020-18, establishing the position and wages of the Village Clerk, and Ordinance 2020-19, establishing the position and wages of the Village Fiscal Officer, and

WHEREAS, the Village Council may combine the positions of Village Clerk and Village Fiscal Officer into a single position, with duties consistent with R.C. 733.262.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of Weston, that:

1. Effective 10/4/21, the positions of Village Clerk and Village Fiscal Officer shall be combined into the position of Village Fiscal Officer, (R.C. 733.262). The Village Fiscal Officer shall be paid an annual salary of \$30,000.00, payable bi-weekly. The Fiscal Officer shall work 35 hours per week, of which not more than five hours per week may be worked from home, at the discretion of the Fiscal Officer.

2. Ordinance 2020-18, establishing the position and wages of the Village Clerk, is hereby repealed, effective 10/4/21.

3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any other committees that results in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

4. This measure is an emergency measure, necessary for the immediate preservation of the health, safety and welfare of the Village and its residents, for the reason that the fiscal records of the Village shall be maintained without interruption to comply with Ohio law.
