## VILLAGE OF WESTON, WOOD COUNTY, OHIO ORDINANCE 2024-18

### ORDINANCE ENACTING AND ADOPTING A SUPPLEMENT TO THE CODE OF ORDINANCES OF THE VILLAGE OF WESTON

**WHEREAS**, the Village of Weston is a statutory municipality located in Wood County, Ohio, with powers of local self-government pursuant to Ohio Constitution Article XVIII, section 3, and

**WHEREAS**, The Village of Weston has adopted the Village of Weston, Ohio, Code of Ordinances, (the "Code"), for the general purpose of promoting and protecting the public health, safety, comfort and welfare of the residents of the Village of Weston, to conserve and protect property and facilitate adequate but economical provision of public improvements; to outline the duties of village officials, and for any other purpose as set forth in the Code, and

**WHEREAS**, the Village of Weston has retained American Legal Publishing Corporation of Cincinnati, Ohio, to complete a supplement to the Code of Ordinances of the Village of Weston, and American Legal Publishing Corporation of Cincinnati, Ohio, has completed said supplement, which contains all ordinances of a general and permanent nature enacted since the prior supplement to the Code, and

**WHEREAS**, American Legal Publishing Corporation of Cincinnati, Ohio has recommended the revision or addition of certain sections of the Code, and

**WHEREAS**, this Council has considered the recommended changes to the Code.

**NOW THEREFORE, BE IT ORDAINED**, by the Council of the Village of Weston, that:


1. That the 2024 S-13 supplement to the Code of Ordinances of the Village of Weston as submitted by American Legal Publishing Corporation of Cincinnati, Ohio, and attached hereto, is hereby adopted.
2. Such supplement shall be deemed published as of the day of its adoption and the Clerk of Council is hereby directed to include such supplement into the Code kept in the office of the Village Clerk.
3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any other committees that results in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
