Ordinance No. 2021-6 Passed September 7, 2021

ORDINANCE TO PROVIDE FOR THE COST AND EXPENSE OF THE LIGHTING OF THE STREETS, ALLEYSWAYS, AND OTHER PUBLIC PLACES IN THE VILLAGE OF WESTON, OHIO; AND DECLARING AN EMERGENCY


BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF WESTON, COUNTY OF WOOD, STATE OF OHIO:

Section 1: That the cost and expense of the lighting of the streets, alleyways, and other public places in the Village of Weston and the furnishing of electrical energy, therefore, for the tax year **2021 in 2022**, be paid for by Special Assessment upon the lots and lands, as listed on the real estate tax duplicate, excluding parcels in an exempt classification, within said Village, and that for such purposes there shall be levied and assessed according to the percentage of the tax valuation of said lots a total amount of **\$26,000.00**.

Section 2: That the council hereby finds and determines that all formal actions relative to the passage of this Ordinance were taken in an open meeting of the Council and that all deliberations of the Council and its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with acceptable legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3: That this Ordinance constitutes an emergency measure, due to the necessity to submit the assessment information to the Wood County Auditor's Office in a timely manner, and therefore shall go into immediate effect upon passage.
