VILLAGE OF WESTON, WOOD COUNTY, OHIO ORDINANCE 2025-3

AUTHORIZING AND DIRECTING THE FISCAL OFFICER TO CREATE A ODNR NATURE WORKS CAPITAL PROJECT FUND WITHIN THE ESTABLISHED FINANCIAL AND BUDGETARY ACCOUNTING SYSTEM FOR THE PURPOSE OF SEGREGATING FUNDS RECEIVED AND EXPENDED FOR THE CAPITAL IMPROVEMENTS TO THE ALUMNI PARK BASKETBALL COURT, AND DECLARING AN EMERGENCY

WHEREAS, the Village of Weston is a statutory village located in Wood County, Ohio, and

WHEREAS, the Village of Weston has powers of Local Self Government pursuant to Article XVIII, Section 3 of the Ohio Constitution and

WHEREAS, the Village of Weston has received approval for grant monies from the Ohio Department of Natural Resources to complete capital improvements to the Alumni Park Basketball Court, and requires the opening of a separate fund to receive and expend monies related thereto.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF WESTON, WOOD COUNTY, OHIO, THAT:

SECTION 1. The Fiscal Officer is hereby authorized to establish within the financial accounting system a revenue fund, number 4901, entitled ODNR Nature Works, for the purpose of collecting and distributing the grant monies and such other monies related to the Alumni Park basketball court resurface and redesign project.

SECTION 2. Ordinance No. 2024-20, the permanent appropriations ordinance for the fiscal year ending December 31, 2025, shall be amended to provide the following appropriations in the account(s) and amount(s) as set forth below:

SECTION 3. The Fiscal Officer shall, if required, request an Amended Certificate of Estimated Resources from the Wood County Auditor's Office to include this new ODNR Nature Works Project Fund.



This measure is an emergency measure necessary for the immediate preservation of the health, safety and welfare of the Village and its residents for the reason that accounting rules require the creation of said Fund at the time of the receipt of such monies, and receipt of the monies is anticipated forthwith.

SECTION 5. It is hereby found and determined that all formal actions of Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Revised Code of Ohio.
