VILLAGE OF WESTON, WOOD COUNTY, OHIO ORDINANCE NO. 2022-27

ORDINANCE MAKING SUPPLEMENTAL APPROPRIATIONS FOR THE FISCAL YEAR ENDING DECEMBER 31, 2022, AND DECLARING AN EMERGENCY

WHEREAS, the Village of Weston is a statutory village located in Wood County, Ohio, and

WHEREAS, the Village of Weston has powers of local self-government pursuant to Ohio Constitution Article XVIII, Section 3, and the Ohio Revised Code, and

WHEREAS, the Village Council adopted permanent appropriations for fiscal year ending December 31, 2022, by Ordinance No. 2022-3, and

WHEREAS, Council has determined that Ordinance No. 2022-3, the permanent appropriations ordinance for the fiscal year ending December 31, 2022, shall be amended to provide for cemetery expenditures.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of Weston, Wood County, Ohio, that:

Section 1: In order to provide for current expenses and other expenditures of the village for fiscal year ending December 31, 2022, Ordinance No. 2022-3, the permanent appropriations ordinance for the fiscal year ending December 31, 2022, shall be amended to provide for the following appropriations in the accounts and amounts as set forth below:

The amounts set forth above as amended appropriations are in lieu of or in substitution for the amounts, if any, appropriated to these account(s) by the permanent appropriations ordinance adopted for fiscal year ending December 31, 2022, and the appropriations contained therein are repealed to the extent of any inconsistency.

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any other committees that results in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Revised Code of Ohio.

Section 3: This measure is an emergency measure necessary for the immediate preservation of the health, safety and welfare of the Village and its residents for the reason that the above accounts must have sufficient balances for the proper expenditure procedures, and the current obligations of the Village must be timely met.


