VILLAGE OF WESTON, WOOD COUNTY, OHIO ORDINANCE NO. 2023-1

ORDINANCE DESIGNATING FIVE PUBLIC LOCATIONS FOR POSTING ORDINANCES, RESOLUTIONS, AND OTHER DOCUMENTS NEEDING PUBLICATION; AND DECLARING AN EMERGENCY

WHEREAS, the Village of Weston, (Village), is a statutory municipality located entirely in Weston Township, Wood County, Ohio, with powers of local self-government pursuant to Ohio Constitution Article XVIII, Section 3; and

WHEREAS, the Ohio Revised Code Section 731.25 provides, in part, that municipal corporations may publish ordinances, resolutions, and other types of documents by posting copies of such in not less than five (5) public places in the municipal corporation for a period of not less than fifteen (15) days prior to the taking effect thereof; and

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of Weston, that:

SECTION 1. The following locations are hereby designated as the locations for posting ordinances, resolutions, and other documents requiring publication in the Village of Weston:

1. Weston Village Hall, 13234 Main Street;
2. Weston Post Office, 13172 Main Street
3. Weston Public Library, 13153 Main Street
4. Weston Maintenance Building, 13145 Main Street
5. www.westonohio.org

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any other committees that results in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Revised Code of Ohio.

SECTION 3. This measure is an emergency measure necessary for the immediate preservation of the health, safety and welfare of the Village and its residents for the reason to continue to provide designated locations within the Village for publications of ordinances, resolutions, and other documents of concern to its citizens, and therefore, shall go into immediate effect upon passage thereof.
