ORDINANCE NO. 2025-8**

**ORDINANCE MAKING SUPPLEMENTAL APPROPRIATIONS FOR THE FISCAL YEAR ENDING
DECEMBER 31, 2025**

WHEREAS, the Village of Weston is a statutory village located in Wood County, Ohio, and

WHEREAS, the Village of Weston has powers of local self-government pursuant to Ohio Constitution Article XVIII, Section 3, and the Ohio Revised Code, and

WHEREAS, the Village Council adopted permanent appropriations for fiscal year ending December 31, 2025, by Ordinance No. 2024-20, and

WHEREAS, Council has determined that Ordinance No. 2024-20, the permanent appropriations ordinance for the fiscal year ending December 31, 2025, shall be amended to provide for the expenditures of the Baseball/Softball Program Fund (2041).

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of Weston, Wood County, Ohio, that:

Section 1: The Fiscal Officer is hereby authorized to certify to the county the reduction of the estimated revenue for the Baseball/Softball Program Fund (2041) to \$0.00.

Section 2: In order to provide for current expenses and other expenditures of the village for fiscal year ending December 31, 2025, Ordinance No. 2024-20, the permanent appropriations ordinance for the fiscal year ending December 31, 2025, shall be amended to provide for the following appropriations in the accounts and amounts as set forth below:
